The O/o Development Commissioner (Handicrafts) Ministry of Textiles, Government of India vide their sanction No. C-11011/7/2015-16-MC-Jodhpur (EPCH) dated 16.06.2015 has approved international marketing intervention of crafts from Jodhpur Mega Cluster under their CHCDS scheme to EPCH. Accordingly Council is inviting applications from members/ members of any relevant Export Promotion Organisation/ stake holders/craftsperson/ small manufacturers.

A built-up booth of 10-12 sq. mtr. would cost approx. Rs.3,50,000/- in **International Furniture Fair-2016** held 10-13 March, 2016 at Singapore. In view of above sanction order above booth is being offered at a highly subsidized **participation charge of Rs.1,50,000/-** for a built-up stand. The selected participants will be entitled for the reimbursement of freight charges upto Rs.70,000/- (or actual whichever is less) for product samples for the above fair and Air ticket by economy excursion class fare and accommodation for one representative of each participating organisation upto Rs.80,000/- (or actual whichever is less). The selected participants will not be entitled for any other subsidy such as MDA or MAI from the council or any other organisation.

However, the other expenses towards specific display aids, personal expenses like visa fee and stay etc. shall be borne by the participants themselves. The Council will issue necessary visa recommendation letter in favour of member exporters. Grant of visa is the discretion of concerned Embassy. The Council reserves the right for selection of participation. If the applicant withdraws their participation after selection, the amount deposited along with application will be forfeited.

The interested applicants from Jodhpur Mega Cluster may please forward their application along with a highly subsidized participation charges of **Rs.1,50,000/-** in favour of EXPORT PROMOTION COUNCIL FOR HANDICRAFTS payable at New Delhi or may be deposited through RTGS as details given attached factsheet. The complete application along with necessary payment should reach to the Council's office latest **by 15/11/2015**.

3. Withdrawal & Refund of Participation Fee: No refund will be considered once the participation has been confirmed by the Council. Members may please note withdrawal after selection will not be allowed. If withdrawn, the amount deposited by the applicants towards their participation shall be forfeited

4. Visa: The Council will provide necessary assistance by way of issuance of recommendation letter to the concerned Mission for obtaining visas. Visa recommendation letter will be issued only in favour of the Chief Executive / Director / Proprietor/Senior Officer of the company.

The approval of participation does not confer any right for grant of visa. No claim for refund of participation charges would be entertained on account of denial/delay of visa .Since space booked on behalf of the participating company, therefore, Council has already committed for certain financial bindings by way of booking of space, construction/decoration of stand, catalogue entry, general publicity support etc., therefore, it will not be possible to consider any refund request on account of denial of visa/delay of visa.
