Council has applied to Ministry of MSME forfinancial support to the exhibitors under their scheme. If approved by MSME, the participation will be subsidised proportionately as per the guidelines of MSME for the eligible manufacturer member exporters having UdyogAadhar issued by Ministry of MSME, Govt. of India. Therefore applicants are requested to fill the MSME form at Annexure-III

- > The proposed participation cost will be **Rs.29,000/-** per sq.mtr. and applicants will have to pay 100% participation charge to the Council prior to participation.
- ➤ The Council will refund uptoRs.1,90,000/- (Rs.1,25,000/- towards space + Rs.40,000/- towards air fare + Rs.25,000/- towards freight charges) to eligible exhibitors on receipt of grant from Ministry of Micro, Small and Medium Enterprises (MSME) after their successful participation.
- Above participation Charges includes standard booth package with limited display aides like as spot light, name fascia, carpet & electric socket.
- Participants have to make their own arrangement/expenses towards Travel, Hotel Accommodation, Shipment / clearing, Customs Duties of exhibits, Visa etc.
- The Council invites application for limited space and reserves the right to select the participants.
- Visa recommendation letter be issued in favour of member organization (Proprietor / Partners / Directors /
 Chief Executive / Senior level officer maximum two only) EPCH shall not be liable in case if visa is not granted
 by the concerned Embassy.Participantswill have no right to claim refund of participation charges if visa not
 granted.
- The participants shall not be eligible for any other financial or travel assistance such as MAI or other state Govt. Grant etc.

Interested members are requested to submit their duly filled application form in the prescribed format (enclosed herewith) along with amount of Rs.1,50,000/- (Rupees One Lakh and Fifty Thousand only) by way of demand draft / pay order / RTGS / NEFT in favour of the Export Promotion Council for Handicrafts payable at New Delhi latest by 30th June, 2019. The participation guidelines as prescribed by the fair organizer shall be applicable. The application form along with general terms & conditions of participation is enclosed.
