During the meeting, the potential for expanding the handicrafts sector through the establishment of incubation centers in cities such as Mumbai, Thane, and Pune was discussed. A proposal to sign a MoU with EPCH was also put forward, dedicated to promoting handicrafts from Maharashtra. These incubation centers would offer design facilities, skill development programs, and other initiatives aimed at fostering growth and innovation in the sector. During the meeting, Mr. Avdesh Agarwal, Chief Convenor, EPCH and Mr. Ravi K Passi, COA Member, EPCH, invited the Government of Maharashtra to actively participate in the upcoming 60th IHGF Delhi Fair - Autumn 2025, scheduled from 13th-17th October 2025, where thematic displays from Maharashtra's crafts sector can be showcased.

**24th July 2025, Mumbai:** An EPCH delegation comprising Dr. Neeraj Khanna, Chairman, EPCH, Mr. Avdesh Agarwal, Chief Convenor, EPCH, Mr. Ravi K Passi and Mr. Pradeep Muchalla, COA members, EPCH; and Mr. Ashok Boob, leading member exporter from Mumbai, met Mr. Deependra Singh Kushwah IAS, Development Commissioner (Industries), Government of Maharashtra, at Mantralaya, Mumbai. The meeting was held to discuss strategies and present detailed suggestions for the growth and promotion of the handicrafts sector in the State of Maharashtra with a focus on enhancing exports of handicrafts from the country.

During the meeting, Dr. Khanna highlighted Maharashtra's significant contribution to India's handicrafts exports, and emphasised the rich heritage of the state reflected in its diverse range of craft products such as tribal jewellery, Warli paintings, musical instruments, bamboo & coconut shell crafts, pottery, Ajanta paintings and more. Dr. Khanna submitted a formal representation on behalf of EPCH, outlining actionable suggestions to overcome current challenges faced by member exporters and artisans in the state. Key recommendations included support through: An Export Policy tailored for the handicraft export sector; Enhanced MDA Scheme; E-commerce export support; Freight subsidy; Export credit insurance reimbursement; Interest subsidy; Design development
