**17th July 2025, Bangalore:** Dr. Neeraj Khanna, Chairman, EPCH, along with Mr. Avdesh Agarwal, Chief Convenor, EPCH; Mr. K N Tulasi Rao, Member COA, EPCH; and Mr. R K Verma, Executive Director, EPCH, held a series of high-level meetings with senior officials of the Government of Karnataka, to discuss strategic measures aimed at enhancing handicraft exports from the state.

Dr. Khanna met with Smt. Uma Mahadevan IAS, Additional Chief Secretary and Development Commissioner Govt of Karnataka; Dr. S. Selvakumar IAS, Principal Secretary to Government, Skill Development, Entrepreneurship & Livelihood Department, Govt. of Karnataka and Smt. Gunjan Krishna IAS, Commissioner, Industries and Commerce Department, Govt. of Karnataka. During the discussions, he presented a comprehensive representation detailing opportunities, challenges and actionable recommendations for strengthening the state's handicrafts sector.

During the meeting, Dr. Neeraj Khanna, Chairman, EPCH, gave an overview of the handicrafts sector highlighting the sector's significant role in employment generation and rural development in major craft clusters. He also presented the sector's recent export performance and shared key challenges faced by exporters such as Market Development Assistance (MDA) Scheme and Exploring Handicraft Markets, Assistance for E- Commerce Exports, Engagement with e-commerce, freight subsidy on shipping of

containers, Export Credit Insurance Support, Interest Rate Subsidy, Assistance to Design Development Measures and Assistance to compliance and others. The officials gave a patient hearing and assured support to the issues raised.

Dr. Khanna extended a formal invitation to the Government of Karnataka to actively participate in the 60th edition of the IHGF Delhi Fair - Autumn 2025, to be held from 13th-17th October 2025, at India Expo Centre & Mart, Delhi-NCR. A dedicated thematic pavilion showcasing Karnataka's rich craft traditions is proposed to further expand market access for artisans from the state.

EPCH looks forward to a strong and collaborative partnership with the Government of Karnataka to boost the growth, competitiveness, and global visibility of its unique handicraft traditions.

Dr. Neeraj Khanna, along with Mr. Avdesh Agarwal, Chief Convenor, EPCH; Mr. K N Tulasi Rao, Member COA, EPCH; and Mr. R K Verma, Executive Director, EPCH, also held an interactive meeting with prominent member exporters from Bangalore, Mysuru and nearby regions. The delegation engaged in meaningful discussions with leading member exporters to understand the key challenges and bottlenecks affecting handicraft exports from the region. Dr. Khanna assured the exporters of EPCH's full support and timely intervention to resolve the issues raised and to further facilitate the growth of handicraft exports from Karnataka. ■
