1st September 2025, New Delhi: A Delegation of wooden handicraft exporters led by Mr. Sagar Mehta, Vice Chairman, EPCH, met met Shri Bhupender Yadav, Hon'ble Minister of Environment, Forest and Climate Change, Govt. of India, to discuss challenges arising from the European Union Deforestation Regulation (EUDR).

The meeting was attended by Mr. Tanmay Kumar, Secretary, MoEFCC; Mr. Sushil Kumar Awasthi, DG Forest; industry representatives including Mr. Hansraj Baheti, COA Member, EPCH; Mr. Naresh Bothra, President, Jodhpur

Handicrafts Exporters Federation; Mr. Raunak Parakh, member exporter from Jodhpur, Mr. Mohd. Ausaf, General Secretary, Saharanpur Wood Carving Manufacturers Association; Mr. Anwar Ahmed, member exporter from Saharanpur; Mr. Sachin Raj Jain, Convenor, Network for Certification and Conservation of Forests: NCCF; along with Mr. R K Verma, Executive Director, EPCH; and Mr. Rajesh Rawat, Addl. Executive Director, EPCH.

EPCH's Vice Chairman apprised the Hon'ble Minister of the sector's export performance and highlighted that EUDR's stringent compliance requirements could adversely impact small and medium exporters. He urged the government for a coordinated national response and constructive engagement seeking an interministerial committee between MoEFCC, MoAFW, MoC&I, Ministry of Textiles/Development Commissioner (Handicrafts) and DGFT to deliver a digital traceability/geo-location framework with a



centralised documentation system; direct state forest departments to capture plot geo-coordinates and felling volumes and make working plans accessible; launching a National Timber Portal System linked to the VRIKSH scheme; publish a licensed sawmill registry with geo-coordinates and deferment or suitable exemptions for wooden handicrafts made from agroforestry based wood such as Mango, Acacia and Sheesham. Mr. R K Verma, Executive Director, EPCH said, "EPCH has always been committed towards aligning with global sustainability frameworks through initiatives like 'Vriksh' Timber Legality Assessment and Verification Scheme, an internationally recognised system that assures the legality and sustainability of wood sourcing. However, large-scale implementation of georeferenced traceability systems requires policy support, funding and international engagement. This collective approach will ensure compliance while safeguarding India's export competitiveness."■

Meeting of Hon'ble Minister of Commerce & Industry with EPCs on Strategies to Enhance Exports and Address Trade Challenges

3rd September 2025: A meeting was convened under the Chairmanship of the Hon'ble Minister of Commerce & Industry, Shri Piyush Goyal, with Export Promotion Councils (EPCs) to deliberate on strategies for enhancing exports and to address prevailing geopolitical and international trade challenges, including the issue of US reciprocal tariffs.

EPCH was represented by Mr. Ravi K Passi and Mr. Rajesh Jain, COA members, EPCH, along with Mr. Rajesh Rawat, Additional Executive Director, EPCH.

During the deliberations, EPCH highlighted several critical measures to mitigate the adverse impact of US reciprocal tariffs. These included provision of 30% Cost Equalization Assistance for exports to the USA, continuation of the Interest Equalization Scheme,

revival of the Section 80HHC Income Tax benefit, grant of a moratorium on loan repayments, constitution of a multi-ministerial Sub-Committee on EUDR, and duty-free import of inputs under the IGCR Scheme.

The Hon'ble Minister gave a patient hearing and assured that the Government remains fully committed to extending all possible support to MSMEs, including the handicrafts sector.

EPCH Urges Extension of Export realization period to 360-Days — without penal interest, Requests Moratorium period on loans to MSMEs

8th September 2025: EPCH has urged for immediate relief measures to preserve liquidity and competitiveness for India's handicraft exporters amid extended buyer payment cycles and global headwinds. In the current scenario, delays in realisation of export proceeds are common and often beyond the control of exporters.

Highlighting exporters' concern Dr. Neeraj Khanna, Chairman, EPCH, shared, "handicrafts exporters are contending with a challenging global environment marked by geopolitical tensions, reciprocal tariffs in key markets, elevated logistics costs and uncertain demand factors that are extending buyer payment cycles beyond exporters control. Under current norms, realisation beyond 270 days attracts penal interest, creating avoidable stress precisely when working capital is most constrained. EPCH urges for a relief framework that sets out a 360-day export proceeds realisation window with uniform

AD-bank implementation with waiver of penal interest on substantiated delays."

Dr. Rakesh Kumar, Director General in the role of Chief Mentor, EPCH and Chairman, IEML shared, "continuing our engagement with policymakers to keep MSME exporters competitive, we have requested a coordinated relief package with the Government of India which includes extending credit realisation timelines and one-year moratorium covering both principal and interest on other loans." He further added, "exporters are battling an unprecedented situation marked by high tariffs, shipment delays and rising costs. Without timely policy support, even fundamentally strong businesses risk being classified as NPAs. Extending credit realisation timelines and granting a moratorium on loan repayments will give exporters the flexibility to diversify markets, comply with new regulations and continue contributing to India's foreign exchange earnings."

and explore mitigation strategies to boost India's exports. During the discussions, Mr. Sagar Mehta, Vice Chairman, EPCH, presented an overview of the sector's export performance and highlighted that the recent U.S. tariff has dealt a major setback to the handicrafts sector. To address this unprecedented challenge, he urged the Government to consider urgent measures such as, Introduction of a 30% Cost Equalisation Incentive; Enhanced benefits under the Interest Equalisation Scheme; Income Tax exemptions in line with erstwhile Section 80HHC of the Income Tax Act; Extension of the export realisation period from 180 to 360 days (without penal

43B of the Income Tax Act; and Active engagement with the European Union to resolve issues related to the EUDR. Mr. Prince Mallik further emphasised the need to incentivise export promotion efforts in BRICS countries,



highlighting them as key emerging markets. The Hon'ble Minister gave a patient hearing and assured due consideration. ■
