Impex # 1 Export limit of free of cost items for export promotion, increased to Rupees one crore

DGFT issues Notification and Public Notice increasing the export limit of free of cost items for export promotion from Rupees 10 lakhs per year to Rupees One Crore (conditions apply). For true evaluation of a product, there is no substitute than to examine it physically in all the relevant details. This becomes all the more important when the buyer is located thousands of miles away. Even slight variations in supplies can be easily detected when compared to the reference sample.

DGFT has recognised the above facts and made a provision for free exports of items in its FTP of 2015-20 in para 3.24 (j). It provides that status holders shall be entitled to export freely exportable items on free of cost basis for export promotion subject to an annual limit of Rs. 10 Lakhs or 2% of average annual export realisation during proceeding three licencing years, whichever is lower.

DGFT has now issued a Notification No. 23/2015-20 dt. 23.08.2017 increasing the above free limit from Rs. 10 Lakhs to Rs. One Crore. This has been done by amending para 3.24 (j) of FTP of 2015-20. The operative part of the notification is reproduced below:

(Extracts)

Amended Para 3.24 (j) of Chapter-3 of FTP 2015-2020:

"Status holders shall be entitled to export freely exportable items (excluding Gems and Jewellery. Articles of Gold and precious metals) on free of cost basis for export promotion subject to an annual limit of Rupees One Crore or 2% of average annual export realisation during preceding three licensing years. whichever is lower. For export of pharma products by pharmaceutical companies, the annual limit would be 2% of the average annual export realisation during preceding three licensing 'years. In case of supplies of pharmaceutical products, vaccines and lifesaving drugs to health programmes of international agencies such as UN. WHO-PAHO and Government health programmes, the annual limit shall be upto 8% of the average annual export realisation during preceding three licensing Nears. Such free of cost supplies shall not be entitled to Duty Drawback or any other export incentive under any export promotion scheme."

Effect of this Notification: Entitlement to export freely exportable items on free of cost basis by Status Holders has been revised.

In this connection DGFT has also issued a Public Notice No. 18/2015-20 dt. 23.08.2017 amending existing para 2.84 of Chapter-2 of HBP of 2015-20 which may also be seen.

It was stated in the above notification that Certificate of Origin (COO) shall be issued by the state govts. The proforma of COO was, however, not given in the said notification.
