40 artisans participated in this awareness seminar organised by EPCH at Chhattisgarh's craft hub, Raipur. Aimed to educate crafts persons/artisans, national awardees, NGOs/SHGs, entrepreneurs and manufacturers in the region, this saw the presence of Mr. S R Masram, Assistant Director, O/o DC (Handicrafts); guest faculty, Mr. Ashok H Sharma from AEC Pvt. Ltd., Mumbai; and EPCH member exporter, Mrs. Anuradha Sahu. The guest speakers shared their views on handicraft development in Raipur with emphasis on its potential to be explored to a business and professional level.

He made the presentation on different market situations and merits in understanding demand and market for handicrafts. He also spoke on packaging as well as



documentation & procedures of export. The presentation on documentation was of notable interest to the artisans. They raised queries on identifying market situations. Mrs. Anuradha Sahu shared her past experience in the field as well as merits of IHGF Delhi Fair and its importance to entrepreneurs.

Time Management for Professionals

Moradabad; Uttar Pradesh 24th January 2018

EPCH organised a seminar on Time Management with expert faculty, Dr. Mosam Sinha, Professor, TMIMT, Moradabad. With an illustrative slide show he described the topic in an interesting & interactive way to the

participants.

Stating that time management is more of an an art than a science, Dr. Sinha in his presentation emphasised how a valuable point that changes life can take place in a single moment.



He explained, that time management is identification of tasks in order of priority so that one can classify the time accordingly under segments of free time or leisure time, routine time and sacrifice time. He advised that one should have consistency in usage of time. In general, due to unexpected turn of events one can lose time from a pre-scheduled time planning. The time so lost due to unexpected events has to be compensated as soon as possible by starting with the most important task, the very next day.

Focusing on the necessity of a time table, he guided the participants on the right attitude(non-egoism) that often comes with an "I know everything" stance; the importance of saying "No" when one is over worked or may not be able to stick to committment due to paucity of time; "I will not take rest until I succeed in this activity" outlook.; as well as clarity on "why I am doing this".

E-way billing in GST Regime - Its role and its compliance for handicraft exporters

This awareness seminar had guest faculty, Mr. Vaibhav Jain inform the participants about E-way billing in the GST regime. The attendees learnt that under GST, member exporters will need to carry an electronic way bill or E -way billing when moving goods from one place to another. Since it is a new rule introduced under GST, it is necessary for all consignors/consignees/transporters to be aware of the required compliance. The rules for implementation of nationwide E-way Bill system for inter-State movement of goods on a compulsory basis will be notified with effect from 1st February, 2018. Mr. Jain covered the topics which included concept of E-way bill, generation of E-way bill, validity, documentation, etc. He further that E-way Bill can be generated on the E-way Bill Portal. Transport of goods of more than Rs. 50,000 in value in a vehicle cannot be made by a registered person without an E-way bill. Alternatively, E-way bill can also be generated or cancelled through SMS, Android App and by Site-to-Site Integration(through API). When an e-way bill is generated a unique eway bill number (EBN) is allocated and is available to the supplier, recipient, and the transporter. Therefore, E-way Bills must be



generated on the common portal for all these types of movements.The implementation of E-way Bill has been postponed for the

time being by the GST Council. The details of E-way Bill are available at *http://www.epch.in/policies/gst/usermanual_ewb.pdf*.

Global online selling through amazon.com

Mr.Gaurav Chauhan from amazon.com made a presentation on how to start online business with amazon.com, a portal that makes selling internationally, simpler and easier, wheather one is new to trading or is a seasoned exporter.Enumerating steps to start selling in three simple ways, Mr. Chauhan suggested starting with the home market before selling internationally; starting slow while maintaining breadth of selection; and adjusting pricing or remove listings when sales spike(to mitigate stock-out risk).

Mr. Ravi Passi, Vice Chairman, EPCH, emphasised on the need for global online selling of handicrafts and stated that a broader selection of products means higher customer search exposure to overall online product listings. This can help one quickly gauge which products which can be successful in a particular marketplace.

The other guest faculty aso guided the attendees on online sales and its implications for one's business, understanding legal and industry requirements concerning sales of products to consumers in home country and overseas as well as exploring online trade channels for maximum reach to potential end users.
