Dr. Kumar requested all the committee members to actively engage in the discussions and place the problems and the suggestions before the Committee which can be addressed and taken up at the highest level so that solutions to problems can be achieved. Some of the key issues discussed during the meeting include: Norms & procedures of pollution & fire department; Regularisation of Factory Maps by Moradabad Development Authority (MDA); High charges by forwarding & shipping lines; Identification of alternate varieties of wood for usage by the sector with FRI & state forest department;



Non-availability of containers for exporters; Delay in settlement of ECGC claims; Non-provision of container freight subsidy; CFC requirement at Firozabad handicrafts cluster; High electricity charges; Maximisation of the benefits of ODOP schemes for U.P. exporters; Requirement of industrial land for Aligarh exporters; Providing skill and design support to the artisans; and Identification of new and latest technologies by the exporters to be introduced in handicrafts sector. The meeting concluded with thanks to all the participants and with a resolve that with active participation of everyone, the exporters will be able to garner maximum support from the Government.

CHEMS classes take virtual route successfully, 3rd batch in progress







30 years, we have carried out various activities to give a fillip to Indian handicraft exports by continuously upgrading skills, backward integrations, forward integrations and imparting training at various levels." Soon after the convocation ceremony, Dr. Kumar was felicitated by the Handicrafts Association of Tamil Nadu, both for receiving the Honoris Causa D. Litt. for his contribution to the handicraft sector. ■

NRF Expects Holiday Sales to Grow

With retail sales rebounding strongly due to continued consumer resilience, the National Retail Federation forecast that holiday sales during November and December will increase between 3.6 percent and 5.2 percent over 2019 to a total between \$755.3 billion and \$766.7 billion. The numbers, which exclude automobile dealers, gasoline stations and restaurants, compare with a 4 percent increase to \$729.1 billion last year and an average holiday sales increase of 3.5 percent over the past five years. NRF expects that online and other non-store sales, which are included in the total, will increase between 20 percent and 30 percent to between \$202.5 billion and \$218.4 billion, up from \$168.7 billion last year.

The forecast comes as NRF's latest research shows 42 percent of consumers started their holiday shopping earlier than usual this year. NRF's "New Holiday Traditions" campaign has urged consumers to shop safe and shop early amidst the pandemic, and 59 percent had begun by early November, up from 49 percent at that point a decade ago.

NRF expects retailers to hire between 475,000 and 575,000 seasonal workers to help accommodate additional demand during the holiday season. That compares with 562,000 in 2019. Some of the hiring may have been pulled forward into October as many retailers have implemented holiday sales campaigns earlier than in the past.
