Subject: Election for the Members of Committee of Administration (COA) of Export Promotion Council for Handicrafts.

Sir/Madam,

In terms of Articles of Association of EPCH and Election Rules-2025, the Committee of Administration has appointed the undersigned as the "Returning Officer" for holding the Election of the Members of Committee of Administration of EPCH. The nominations (Form-II) will be received as per the enclosed Notice of Schedule for Election (Form-I) in the Council's office at EPCH House, Pocket 6 & 7, Sector – C, LSC, Vasant Kunj, New Delhi – 110070. A copy of the Election Rules-2025 has already been circulated by EPCH to concerned members in advance vide Email Circular dated 6th December, 2025 and the same is also placed on website www.epch.in. An updated Electoral Roll has been placed on EPCH website.

As per Article 24.7(a) of Memorandum and Article of Association of EPCH "The Election of the members of the Committee of Administration shall be held at the end of every term to elect new members in place of those who are retiring, as per Election Rules so framed by COA and circulated in advance. Eligible members shall be entitled to vote at the time of the election of COA by electronic means of e-voting process and the procedure as contained in Companies Act, 2013". Therefore, as per the above Memorandum and Article of Association and Election Rules-2025 circulated to members, there shall be the election of eight vacancies (Six retiring members and two reserved seats) for the members of the Committee of Administration. Accordingly, the details of retiring members of the Committee and the region from which such members are retiring and the availability of the eight vacancies in the region(s) are given below:-



As per Memorandum and Article of Association and Election Rules of EPCH "The contesting candidate must have annual average export performance during the two financial years immediately preceding the election of the Handicrafts products (as defined 2T of FTP time to time) of not less than Rs. 15 Lakh."


