At glance: The Republic of Turkey is a large peninsula that bridges the continents of Europe and

Turkey is located on the Anatolian peninsula in western Asia and a small enclave in Thrace in the Balkan region of Southeast Europe and surrounded on three sides by the Black Sea, the Mediterranean Sea, and the Aegean Sea. Because of its location in the Middle East, Turkey is strategic in world affairs. Turkey is a member of the North Atlantic Treaty Organization (NATO) which is a defense alliance. Turkey is one of the most earthquake prone areas on Earth and has suffered many earthquakes in the past Turkish recent years. The modern republic, founded in 1923 after the collapse of the Ottoman Empire, is a nationalist, secular, parliamentary

democracy. The capital is Ankara, and its largest city and seaport is Istanbul.
